It was **AGREED** to adopt the assets register (P: PD, S: VA). The Clerk was asked to enquire with Charles Armstrong as to what arrangements were agreed for ownership and insurance of the Uppington play area at the time of it being installed.

An insurance quote had been received from Aviva on a 3 year arrangement whereby the cost was £180 in Year 1, rising to £230 in year 2 and £265 in Year 3. This included insurance for the play area for both public liability and replacement value. It was **AGREED** to accept this quote unless the quote awaited from Zurich was cheaper.

Priority 1	B4380 Donnington junction on to Ironbridge Road	Visibility on the bend in the context of speeding Going right towards Shrewsbury & checking for traffic towards Telford it is not possible to see oncoming traffic. There is no slow sign on the approach bend. There have been a number of collisions or vehicles losing control and leaving carriageway at this junction.			
Priority 2	Coalpits crossroads where Dryton road meets B4380	Concern re speeding traffic at junction with restricted vision.			
Priority 3	Bends on B5061 between the junctions with B4394 and B4380	Concern regarding number of traffic incidents with collisions, vehicles leaving the road, near misses and the very high speeds of vehicles on this road.			
Priority 4	Patch Lane junction with B4380	Risk of hits from the left. Would benefit from a mirror being installed or vision splay in direction of Attingham

## (i) End of year accounts

The internal auditor has raised concerns regarding the low level of the Council's reserves. It was **RESOLVED** to approve and sign Sections 1 and 2 of the end of annual audit return for the year ended 31<sup>st</sup> March 2014; the Chairman and Clerk duly signed the return (P: LD, S: VA). The end of year bank reconciliation, budget report and variances explanation were also approved and signed, showing an end of year balance of £566.12, payments totalling £5049.22 and receipts totalling £2942.12 during 2013/14.

## (ii) Appointment of internal auditor for 2014/15

It was **RESOLVED** to appoint Sue Hackett (P: PD. S: SR).

## (iii) IT equipment

It was **RESOLVED** to lease the use of Clun Town Council's laptop and printer from May 2014 until end of July 2015 at a cost of £18.44. Should the Council wish to withdraw from the lease early, a refund would be issued. This would be based on the depreciated value of the equipment, calculated based on a 3 year lifespan since purchase in August 2012 and it depreciating on a monthly basis over 36 months.

## (iv) Grant to Uppington PCC

It was **RESOLVED** to award a grant of £150 to Uppington PCC, for churchyard maintenance, using powers under LGA 1972, S. 215 (P: LD, S: PD).

## (v) Council's bank balances
