APM 010/1415 PARISH PRECEPT

In order to provide adequate funds to meet the Council's running costs and continue to provide a range of facilities for the community, a decision had been taken to raise the precept. The Council holds reserves to act as a contingency fund. However, reserves are very low and the auditor has advised that they need to be increased.

APM011/1415 REPORT ON DONNINGTON EXHIBITION FOUNDATION CHARITY

The Donnington Exhibition Foundation charity exists to provide grants for young people in education. The charity has not received any applications for funds in recent years and is looking to close. The Parish Council had decided that it would support the charity in this decision

APM012/1415 HIGHWAYS MATTERS
